BUSINESS MISSION MOROCCO AND LIBYA, JUNE 3 – JUNE 11

The Canada-Arab Business Council (CABC) is planning a mission of Canadian business and government leaders to Libya and Morocco.

Leaders of the Mission:

- The Honourable Mark Eyking, Parliamentary Secretary to the Minister of International Trade, and
- Dwain Lingenfelter, Chairman & CEO of CABC and Vice President, Government Relations, Nexen Inc.

Partner Organizations:

- Foreign Affairs Canada and International Trade Canada
- Canadian Manufacturers & Exporters

The Mission is intended to assist experienced companies in this region to make new contacts and/or reinforce existing relationships, as well as introduce new companies to these rapidly expanding markets.

The CABC has an extensive network of contacts in each country. Combining these networks with the leadership of Parliamentary Secretary Eyking, who has special responsibility for emerging markets; mission participants can expect access to government and private sector clients at the highest level.

Business opportunities for Canadian firms cover major sectors and include but are not limited to:

- Mining and Energy (including oil & gas)
- Telecommunications
- Engineering and Project Management
- Education / Training

The Mission is aimed at senior executives of Canadian firms already active in these countries, as well as Canadian exporters exploring these growing markets for the first time.

Depart Tripoli to Casablanca, Morocco on June 8, 2005
Arrive in Casablanca on June 8, 2005
Depart Casablanca on June 11th, 2005

A mission hotel will be selected in each city based on a preferred group rate to be provided upon registration. However, *participants are responsible for their own hotel booking*. Once the group booking has been made, **you must guarantee your reservation with a credit card to each hotel.**

All other expenses, including visas and medical insurance must be covered by each participant.

Visa Requirements: A Canadian passport valid for at least six months after arrival in each country.

For Libya, visitor visas are required. **Visas may be obtained by contacting the Consular Section of the People's Bureau of the Great Socialist People's Libyan Arab Jamahiriya in Ottawa:**
